They require you to fill out their forms and fax it to them, so they know who is responsible for food items at your booth. Please do not assume they will not be at the event for inspections, they supervise our event annually. Your compliance is appreciated. Food vendors who currently have a permit must display their permit in their booth as well.

Vendors are responsible for obtaining all clearances from Environmental Health and must comply with regulations. Vendors are also responsible for providing covers, tables, and any other materials needed to display or sell food or goods. All merchant vendors must display their sellers permit or have it available in case of inspection from the State Board of Equalization.

ALL VENDORS NEED TO PROVIDE THEIR OWN POWER SOURCE. Max tent size: 12' x 12'.
